INTERNET SHORT FILM DISTRIBUTION AGREEMENT

I, _____ (the "Contributor"), hereby grant to Animator's Unite, Inc., a New York not for profit incorporation ("Animators Unite"), a nonexclusive, worldwide, perpetual license, without restriction, to reproduce, prepare derivative works based upon, distribute copies of, perform publicly, display publicly, and perform by means of digital audio and/or video transmission the short film entitled " _____ " (the "Film"), a copy of which you have delivered to us in the following format: [VHS, MiniDV, DVD, etc.] The license you are granting to Animators Unite includes the license to offer the Film in any and all formats including, but not limited to, Streaming and downloading over the Internet, theatrical, television, satellite, DVD, CD ROM, videotape and any other methodology, whether now known or hereafter developed. Used herein, "Streaming" means the delivery of audio and/or visual programming whether in real time or by program download (including, but not limited to, RealVideo, any format that operates on the Windows Media Player or any other streaming or direct download audio and/or visual software) through the data delivery protocol known as Transmission Control Protocol /Internet Protocol or any successor or replacement protocol to any recipient for purposes of viewing.

The Contributor further grants to Animators Unite the right to authorize customers to make copies of the Film for personal use including the right to copy the Film onto a DVD or other format (to allow downloading from the Internet and viewing on television or for any other personal use). The Contributor also grants to Animators Unite the right to superimpose a logo and/or watermark on the Film. The Contributor also grants to Animators Unite the right to use portions of the Film and the name and images of individuals and characters appearing in the Film to promote both the Film and "www.animatorsunite.com," including any other sites accessible over the Internet or other networks that Animators Unite may establish (the "Web Site").

In return for the rights granted herein, Animators Unite agrees to consider the Film for use on the Web Site, and, if used, to attribute authorship of the Film to the Contributor.

This agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and may not be amended except in a writing signed by both parties. This agreement and the rights granted hereunder may not be assigned by either party without the prior written consent of the other, which shall not be unreasonably withheld.

The Contributor represents and warrants that (i) the Contributor owns all proprietary rights in the Film, (ii) there are no restrictions against the Contributor granting the rights to Animators Unite that the Contributor is granting hereunder, (iii) the Contributor owns the copyrights in the Film and they have not passed into the public domain, (iv) there are no liens or encumbrances on the Film, (v) the producers, directors, writers, actors, actresses, crew,

and other people that have contributed to the Film have all assigned any and all copyrights in the Film to you in writing, (vi) the Contributor has not licensed any rights in the Film to anyone else that would prohibit the Contributor from licensing the rights that the Contributor is granting to Animators Unite hereunder, and (vii) the Contributor has obtained, or prior to delivery of the Film will obtain, and will provide Animators Unite with copies of, all necessary releases, waivers and assignments so that Animators Unite may freely display the Film without further obligation or payment to any person or entity. The Contributor agrees to indemnify, defend and hold harmless Animators Unite against any claims, losses or expenses (including, without limitation, legal fees) arising out of any breach by the Contributor of any of the Contributor's representations, warranties or obligations set forth in this agreement.

All rights granted hereunder shall remain in effect for the full term of the copyright of Your Film so long as the copyright exists in any country of the world.

Notwithstanding any other term hereunder, Animators Unite is not obligated to exploit Your Film in any manner.
